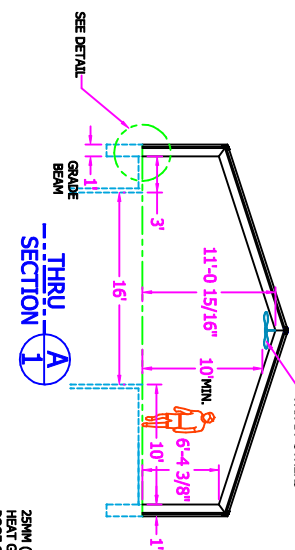
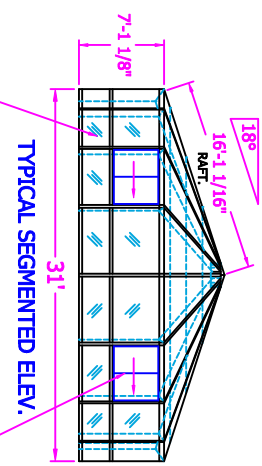

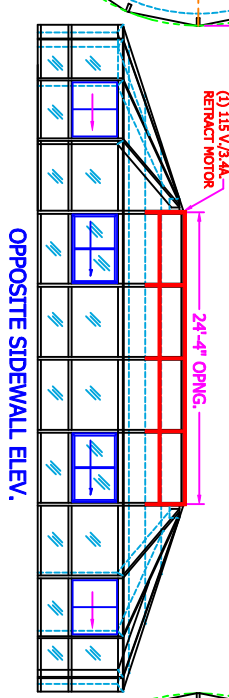


TYPICAL SEGMENTED ELEV.

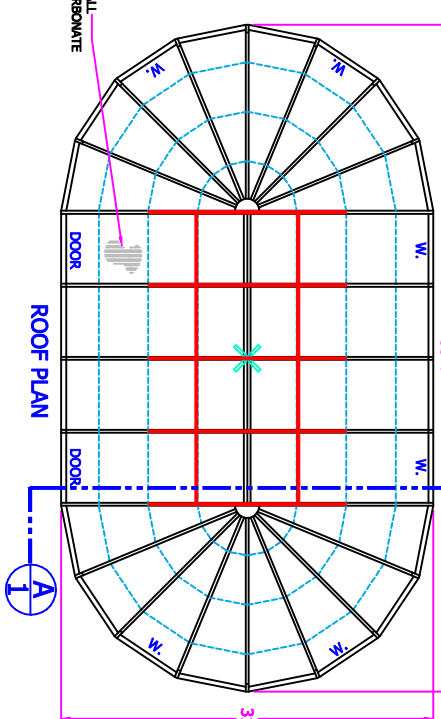

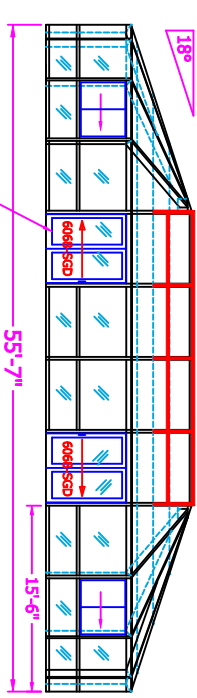

OPPOSITE SIDEWALL ELEV.



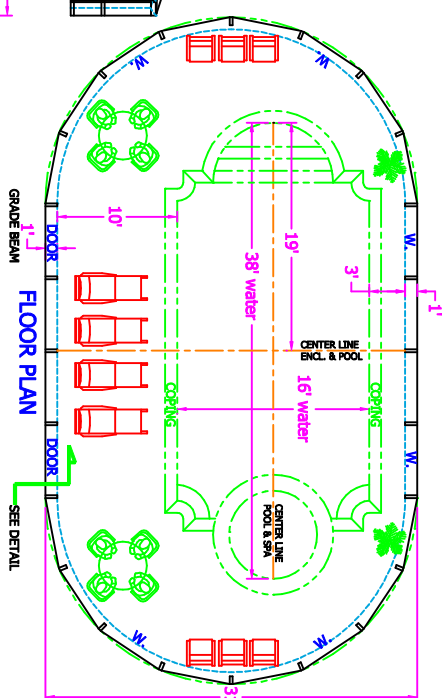
ROOF PLAN



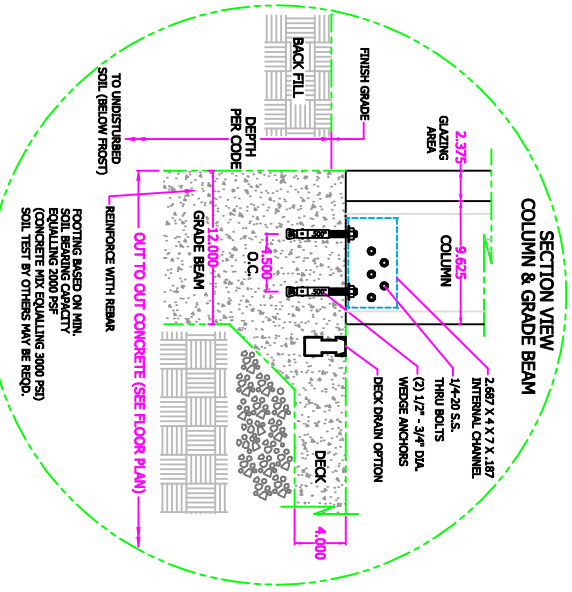
SIDEWALL ELEV. @ HOUSE

- NOTES:
1. THE ENCLOSURE REQUIRES A SQUARE & LEVEL SURFACE TO +/- 1/8" OVER THE ENTIRE AREA OF THE FOUNDATION.
 2. THE LOCATION & SITE WORK MUST COMPLY WITH LOCAL BUILDING CODES AND ZONING ORDINANCES. THE SITE CONDITIONS SHOULD ALLOW FOR THE CONSTRUCTION OF A FOUNDATION WITH THE FOLLOWING EFFICIENCY, SUCH AS BACK FILLING AROUND FOUNDATIONS, UNLOADING, ETC.
 3. FOOTING DEPTH AND SIZE ARE TO BE PER LOCAL BUILDING CODES/PROST LINE ETC.
 4. CONCRETE DECK MUST BE REINFORCED BEFORE DELIVERY (SEE ROLLING SCRAPLOADING).
 5. ANY DELAYS INCURRED DUE TO FACTORY OR SITE CONDITIONS, CONTACT THE EXISTING BLDG. OWNER FOR A WRITTEN APPROVAL OF THE DELAY.
 6. REVIEW FOOTING DETAILS THOROUGHLY, MIN. WIDTH, ABSOLUTE REVEAL, ETC.
 7. IMPORTANT! ALL CONCRETE WORK IS THE RESPONSIBILITY OF OWNER OR G. C.
